- ii) the revalidation/authorization of unspent balance amount of Rs 0.167 lakh (Rupees Sixteen Thousand and seven Hundred Only) of 2013-14 for introduction of Hand Driven Chaff Cutters a component of the Centrally Sponsored "Fodder and Feed Development Scheme in favour of Director Sheep Husbandry Kashmir for purchase of Hand Driven Chaff Cutters and its distribution in favour of Director Animal Husbandry Kashmir.

The above sanction is subject to the fulfilment of all codal formalities, procedural norms with the following conditions:-

1. The expenditure shall be restricted as per the guidelines of the scheme on the approved components / activities and no deviation of funds is allowed in any case;
2. Monthly Physical and Financial Progress Report and cumulative expenditure and physical achievements (component - wise) shall be submitted to the Nodal Officer (Director Sheep Husbandry Kashmir)/ Administrative Department as per prescribed format.

4. Utilization Certificate may positively be submitted before 31.01.2015 for submission to Government of India with a copy to Finance Department; and
5. The Accounts Officer concerned shall vouchsafe the utilization of funds as per codal procedure and as per Government of India's guidelines.
