Sanction is here by accorded to the revalidation of **Rs. 706.458 lakh** (Rupees Seven Crore Six Lakh Forty Five Thousand Eight Hundred Only) unspent of 2016-17 as central assistance for Development of Fisheries under the Central Sector Scheme "**Blue Revolution**"-Integrated Development and Management of Fisheries, in favour of Director Fisheries, J&K, Srinagar for its utilization during the current financial year 2017-18 on the approved components / activities as per the approved Action Plan.

- iii. That the Head of Department shall send utilization certificate of the funds released as early as possible, and definitely well before 31.03.2018;
- iv. That the Accounts Officer concerned shall vouchsafe the utilization of funds as per codal procedure/ Government of India's guidelines;
- v. That the drawing and disbursing officer shall ensure that funds released are utilized prudently and judiciously and in no case they should book the expenditure just for the sake of spending;
- vi. That the HODs shall furnish monthly progress report (both physical and financial) to the Administration Department for its submission to Government of India.
