5. All other relevant documents as are required under SRO 43 of 1994
6. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.

If, on verification, the certificate(s) produced by the appointee is/are proved to be fake or forged, the appointment shall be cancelled *ab-initio*.

The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report about the verification of her character and antecedents is received from the Inspector General of Police, CID to whom a reference shall be made by the Director, Fisheries J&K Srinagar.
