6. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.

If, on verification, the certificate(s) produced by the appointee is/are proved to be fake or forged, the appointment shall be cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report about the verification of her character and antecedents is received from

the Inspector General of Police, CID to whom a reference shall be made by the Director  
Sheep Husbandry Department, Jammu.
