Sanction is hereby accorded to the:

- a. Purchase of one vehicle under replacement for an amount of Rs 7.00 lac (Rupees Seven Lakh Only) under Capex Budget 2015-16 State Sector, in favour of Director Animal Husbandry Kashmir for official use through State Motor Garages.
- b. Advance drawal of Rs 7.00 lac (Rupees Seven Lakh Only) out of the funds already released vide Government Order No. 100-ASH of 2015 dated 11.08.2015 under the head "**Purchase of Vehicles**" in favour of Director Animal Husbandry Kashmir for the aforementioned purpose.

The above sanction is subject to the following conditions:-

- i) That the purchase is made through State Motor Garages.
- ii) No Post of driver shall be created to man the said vehicle.
- iii) That the condemned vehicle is put to auction and proceeds thereof credited to the State Account
- iv) That the Accounts Officer of Directorate of Animal Husbandry Kashmir shall vouchsafe the availability of the funds as per codal procedures.
- v) No liabilities should be created.
- vi) Red account of the above amount shall be furnished to Principal Accountant General, J&K within stipulated time under intimation to the Administration Department.
- vii) No diversion of fund is allowed and there shall be no re-appropriation at any level.

These issues with the concurrence of Finance Department conveyed vide their U.O. No. FD-VII-13(13) 2008 dated 22.01.2016 and Financial Advisor/CAO, Animal/Sheep Husbandry Department dated 28.01.2016.
