Whereas, Dr. Mohammad Ramzan Director Sheep Husbandry Department Kashmir was appointed as Inquiry Officer vide Government order No.158-ASH of 2017 dated 15.11.2017 for conducting regular departmental enquiry against the delinquent officers/officials of Sheep Breeding Farm, Hardshiva for alleged dereliction of their duties.

Whereas, the Inquiry officer after conducting a detailed enquiry into matter has furnished his report vide No. DSHK/Gen-11/G/15194 dated 23.12.2017 and has recommended reinstatement of all the officers/officials.

Now, keeping in view the recommendation of Inquiry Officer sanction is hereby accorded to the reinstatement of the following officers/officials who were placed under suspension vide Govt. order No. 157-ASH of 2017 dated 15.11.2017 with immediate effect:-

Mr. Abdul Rashid, Flock Inspector is however reinstated w.e.f. his date of retirement i.e 31.12.2017. The reinstatement of all officers/officials shall be subject to the following conditions:-

- a) One Annual increment of all the above officers/officials except Mr. Abdul Rashid, Flock Inspector shall be kept withheld.
- b) Behak T.E of all the suspended employees shall be forfeited and period of suspension alongwith behak period w.e.f 15.06.2017 to 17.08.2017 shall be treated as on leave whatever due to them.
- c) All the above officers/officials shall remain careful in future while discharging their duties and not to repeat such instance in future.

Consequent upon his reinstatement, Dr. Peer Irshad Ahmad is transferred and posted as I/c Assistant Director, Rabbit Extension Farms Wussan, Baramulla against available vacancy.

It is further ordered that all the Non-Gazetted employees/ASM's shall be shifted to some other place with suitable replacement by Director Sheep Husbandry Kashmir.

Further, Dr. Nighat Wafai, I/c Joint Director Farms Kashmir is warned to remain careful towards her official duties in future.
