In supersession of Government order No. 143-ASH of 2012 dated 03.09.2012 and in pursuance of the provisions of the SRO-43 dated 17.2.2004, the following Committee at the Divisional Level is hereby re-constituted to consider the release of Time Bound Promotion of Gazetted Officers in Animal / Sheep Husbandry Department:-

KASHMIR DIVISION

1. Director, Animal Husbandry Department Kashmir - Convener
2. Director, Sheep Husbandry Department Kashmir
3. Financial Advisor & CAO of the Administrative Department
4. Representative from Administrative Department not below the rank of the Deputy Secretary.

JAMMU DIVISION

1. Director, Animal Husbandry Department Jammu - Convener
2. Director, Sheep Husbandry Department Jammu
3. Financial Advisor & CAO of the Administrative Department
4. Representative from Administrative Department not below the rank of the Deputy Secretary.

The Committee shall inter-alia consider the following criteria for clearance of time promotion cases within the Department:

- i) Scrutiny of APRs preceding five years of eligibility
- ii) Latest Vigilance Clearance
- iii) Work & Conduct / Integrity certificate to be certified by the concerned HoD.
- iv) Departmental inquiry status of the officers.
- v) Whether any officer has been suspended / charge sheeted / cases challaned in the court of law.
- vi) Details of the complaints pending against the officers and their status.
- vii) Performance of the officers

- viii) Whether the officer has complied with the orders issued by the Government / Directors from time to time in the interest of administration.
- ix) Details of Dies-Non, if any.
- x) Any other issue which the committee may consider necessary.

The Committee shall adhere to all other provisions of SRO-43 dated 17.02.2004 and those directions as may be issued by the Government from time to time.

The Committee shall meet at least twice in a year probably in the months of January and July.


