Sanction is hereby accorded to the:

- a. Purchase of **One unit of Force Traveller Van (Vaccine delivery Van)**) for an amount of **Rs 11.00 lac** (Rupees Eleven Lakh Only) under the "National Mission for Protein Supplements" (NMPS) a sub component of the Centrally Sponsored Scheme "Rashtryia Krishi Vikas Yojana" (RKVY) in favour of Director Animal Husbandry Kashmir through State Motor Garages.
- b. Advance drawal of **Rs 11.00 lac** (Rupees Eleven Lakh Only) out of the funds already released/revalidated vide Government Order No. 132-ASH of 2015 dated 18.09.2015 under the head "Strengthening of Vaccination programme by provision of one vaccine delivery van in favour of Director Animal Husbandry Kashmir.

The above sanction is subject to the following conditions:-

- i. That the purchase shall be made within a ceiling of Rs. 9,62,236/- and rest of the amount should be utilized on registration, insurance, fabrication and accessories of the vehicle;
- ii. That the purchase is made through State Motor Garages.
- iii. That no creation of post of driver is involved;
- iv. That the vehicle be used only for strengthening of vaccination programme;
- v. That the condemned vehicle is put to auction and proceeds thereof credited to the State Account
- vi. That the Accounts Officer of Directorate of Animal Husbandry Kashmir shall vouchsafe the availability of the funds as per codal procedures.
- vii. No liabilities should be created.

viii. Red account of the above amount shall be furnished to Principal Accountant General, J&K within stipulated time under intimation to the Administration Department.

ix. No diversion of fund is allowed and there shall be no re-appropriation at any level.


