Sanction is hereby accorded to the:

- a. Purchase of six vehicles (3 units of TATA Sumo Gold CXPS & 03 units of Maruti Eco 5 Seater STD) under the Centrally Sponsored Scheme "Rashtryia Krishi Vikas Yojana" (RKVY) in favour of Director Animal Husbandry Kashmir;
- b. Advance drawal of **Rs 27.00 lakh** (Rupees Twenty Seven Lakh Only) out of the funds already released vide Government Order No. 113-ASH of 2016 dated 25.10.2016 under the head "Strengthening Veterinary Ambulatory Services in Peri-urban Areas" in favour of Director Animal Husbandry Kashmir for purchase of the above said vehicles.

The above sanction is subject to the following conditions:-

- i. That the purchase shall be made through State Motor Garages;
- ii. That no post of driver is created to man the vehicles;
- iii. That the availability of funds shall be vouchsafed jointly by Deputy Director (Planning) & the concerned Accounts Officer;
- iv. No liabilities should be created;
- v. That the scheme provides for the purchase of these vehicles;
- vi. That the funds shall be utilized by the Directorate strictly as per Rashtryia Krishi Vikas Yojana guidelines;
- vii. Red account of the above amount shall be furnished to Principal Accountant General, J&K within stipulated time under intimation to the Administration Department; and
- viii. No diversion of fund is allowed and there shall be no re-appropriation at any level.

This issues with the concurrence of Finance Department conveyed vide their U.O. No. FD-VII-13(37) creation dated 29.03.2017.


