Sanction is hereby accorded to the release of Rs. **8.16 Lakh** (Rupees eight lakh sixteen thousand only) as matching state share in respect of the unspent central share of 2016-17 of Rs. 81.60 lakh revalidated by the Agriculture Production Department vide Govt. Order No. 179-Agri of 2017 dated 18.07.2017 under Centrally Sponsored Scheme "Rashtriya Krishi Vikas Yojana" (RKVY) for Foot & Mouth Disease Control Programme (FMD-CP) for utilization during 2017-18 for the Action Plan approved by the State Level Sanctioning Committee (SLSC) of the State in the meeting held on 29-11-2016 in favour of the Director Animal Husbandry Jammu:-

The release of funds is subject to the fulfilment of all codal formalities, procedural norms and the following conditions:-

- i. That the funds shall be utilized as per the approved work plan 2016-17;
- ii. That the Head of Department shall ensure that project-wise accounts are maintained and are subject to normal process of statutory Audit, an inventory of the assets created under the projects be preserved and assets that are no longer required shall be transferred to the Nodal department for its use and re-deployment, wherever possible;
- iii. That the HOD shall implement the programme / activities / components on the cost norms / guidelines / subsidy component at par, which is admissible / permissible in the normal Centrally Sponsored Schemes RKVY Plan ;
- iv. That the Drawing and Disbursing Officer shall ensure that funds released are utilized prudently and judiciously and in no case they should book the expenditure just for the sake of spending;
- v. That the HOD shall restrict the expenditure to the actual availability of funds and no liability shall be created in any case;
- vi. That the HOD shall ensure that there is no overlapping / duplication in adoption of scheme / incurring of expenditure from any other scheme of the State or Central Government;
- vii. That the HOD shall furnish monthly progress report (both physical and financial) to the Administrative Department for its submission to Agriculture Production Department and Government of India;

viii. That the Department shall furnish utilization certificate by or before 31.03.2018 alongwith physical and financial progress reports;


