In continuation to Government Order No. 22-ASH of 2018 dated 02.02.2018, sanction is hereby accorded to the Advance drawal of **Rs 8.00 lakh** (Rupees Eight Lakh Only) in favour of the Director Sheep Husbandry, Jammu for "purchase of new Ambulance for Sheep Husbandry unit at Thakarie" during the current financial year 2017-18.

The above sanction is subject to the fulfilment of all codal formalities, procedural norms and the following the:-

- i. That the purchase shall be made through State Motor Garages;
- ii. That no post of driver is created to man the vehicle;
- iii. That the concerned Accounts Officer shall vouchsafe the utilization of funds as per codal procedure and submit the red account to the office of Principal Accountant General thereby adjusting the advance drawal immediately under intimation to the Administrative Department;
- iv. That the funds shall be utilized for the purpose for which they are meant for and expenditure shall be incurred strictly under rules after completing all codal formalities, procedural norms, financial rules and regulations issued by Government from time to time;
- v. That no diversion of funds is allowed and there shall be no re-appropriation at any level and no liability should be created;
- vi. That the funds are available for the current financial year 2017-18 for the said purpose under the relevant Head of Account/Scheme;
- vii. That the condemned vehicle, if any, is put to auction and auction proceeds remitted in Government Treasury;
- viii. It should be ensured that there is no overlapping of funds from any other source such as SDRF, District Plan, CSS, BSDP, PM's Package, CDF, MPLADS, et;
- ix. Financial norms approved under the scheme, as well as adherence to scheme guidelines and submission of pending UCs, if any; and

x. That any un-utilized amount shall be deposited in the treasury.


