- iv. That no diversion of funds is allowed, there shall be no re-appropriation at any level and no liability should be created; and
- v. That the condition laid down in the Govt. order No.120-ASH of 2017 dated 05.09.2017, issued under endorsement No.ASH/Plan/58/2014(P-II)dated 05.09.2017 shall be strictly followed in letter & spirit while implementing the scheme.


