In continuation to Government Order No. 48-ASH of 2018 dated 07.03.2018, sanction is hereby accorded to the advance drawal of Rs 3.00 lakh (Rupees Three Lakh Only) under the Centrally Sponsored Scheme "National Livestock Mission" in favour of Director Sheep Husbandry, Jammu for incurring the expenditure for organizing Ram/Buck Shows during 2017-18, out of the funds already released vide Government Order No. 19-ASH of 2018 dated 01.02.2018, issued vide endorsement No.ASH/F/Plan/31/2014-II.

The advance drawal sanction is subject to the following conditions:-

- i. That the funds shall be utilized for the purpose for which they are meant for and expenditure shall be incurred strictly under rules after completing all codal formalities, procedural norms, financial rules and regulations issued by Government/Finance Department from time to time;
- ii. That the detailed adjustment account shall be rendered immediately after the expenditure is incurred to the Principal Accountant General, J&K under intimation to the Administration Department;
- iii. That the funds are available for the current financial year 2017-18 for the said purpose under the relevant Head of Account/Scheme;
- iv. It should be ensured that there is no overlapping of funds from any other source such as SDRF, District Plan, CSS, BSDP, PM's Package, CDF, MPLADS, etc;
- v. The Utilization Certificate alongwith the Physical Progress Report shall be furnished to the Administrative Department by or before 31.03.2018, for its submission to the Government of India;
- vi. That no diversion of funds is allowed and there shall be no re-appropriation at any level and no liability should be created; and
- vii. That the condition laid down in the Govt. order No. 19-ASH of 2018 dated 01.02.2018, & No. 33-ASH of 2018, dated 23.02.2018 shall be strictly followed in letter & spirit while implementing the scheme, and
