- Release of Rs. 11.25 Lakhs (Rupees Eleven Lakh Twenty Five Thousand only) as interest free loan in favour of Managing Director, Sheep and Sheep Products Development Board for meeting expenditure on account of salaries and wages bills of its employees during current Financial Year, 2017-18.
- Advance drawal of Rs. 11.25 Lakhs (Rupees Eleven Lakh Twenty Five Thousand only) by Director Finance, Animal / Sheep Husbandry Department for placement of funds with Managing Director, J&K Sheep and Sheep Products Development Board, since the J&K Sheep & Sheep Product Development Board does not operate upon the treasury.

The Board shall ensure that 25% of the Budgetary Support is to be earmarked for meeting statutory liabilities of the retired employees of the Board.

The Board shall also ensure that the current EPF / GPF shall be the first charge on the amount so released and only after paying the same the balance is to be utilized by the Board. The Budgetary Support shall be further subject to the conditions as laid down in the Government Order No.45-F of 2002 dated 27.03.2002.
