In terms of the J&K Compassionate Appointment Rules, 1994, notified vide SRO-43 dated 22.02.1994, as amended from time to time, sanction is hereby accorded to the temporary appointment of Mr. Mohd Ashraf S/o Late Mohd Shabir (Ex-Assistant Stockman) R/o Judda, Tehsil Arnas, District Reasi as Assistant Stockman in the Pay Band of Rs. 4440-7440 with the Grade Pay of Rs. 1400/- in the Sheep Husbandry Department in District Reasi, in relaxation of the prescribed qualification in terms of Rule-7 under SRO-43 of 1994.

The appointee shall report to the Director Sheep Husbandry Department, Jammu within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production and verification of the following documents/certificates:-

1. Age and Health Certificate.
2. Permanent Resident Certificate
3. Dependent Certificate issued by the Assistant Commissioner Revenue.
4. All other relevant documents as are required under SRO 43 of 1994
5. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.

If, on verification, the certificate(s) produced by the appointee is/are proved to be fake or forged, the appointment shall deemed to be cancelled *ab-initio*.

The salary of the appointee shall not be drawn and disbursed unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police, CID to whom a reference shall be made by the Director, Sheep Husbandry Department, Jammu.


