In terms of the J&K Compassionate Appointment Rules, 1994, notified vide SRO-43 dated 22.02.1994, as amended from time to time, sanction is hereby accorded to the temporary appointment of Smt. Razia Begum W/o Late Mir Wali (Ex-Assistant Stockman) R/o Pogal, Tehsil Pogal Peristan (Ukhral) District Ramban as Assistant Stockman, in the Pay Band of Rs. 4440-7440 with the Grade Pay of Rs. 1400/- in Sheep Husbandry Department, in District cadre Ramban, in relaxation of the prescribed qualification in terms of Rule-7 under SRO-43 of 1994.

The appointee shall be on probation for two years and shall report to the Director Sheep Husbandry Department, Jammu within a period of 21 days from the date of issuance of this order. She shall be allowed to join only on production of the following documents/certificates which shall be subsequently verified by the Director Sheep Husbandry Jammu:-

1. **Age and Health Certificate.**
2. **Permanent Resident Certificate**
3. **Dependent Certificate issued by the Assistant Commissioner Revenue.**
4. **All other relevant documents as are required under SRO 43 of 1994**
5. **No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.**

If, on verification, the certificate(s) produced by the appointee is/are proved to be fake or forged, the appointment shall deemed to be cancelled

ab-initio.

The salary of the appointee shall not be drawn and disbursed unless a satisfactory report about the verification of her character and antecedents is received from the Inspector General of Police, CID to whom a reference shall be made by the Director, Sheep Husbandry Department, Jammu.
