Whereas, vide Government Order No.142-ASH of 2016 Dated: 31.12.2016, Dr.Raj Kumar Gupta, was transferred and posted as Officer Incharge, Artificial Breeding Station, Surankote but he did not join at his new place of posting as reported by the Chief Animal Husbandry Officer, Poonch;

Whereas in the mean while Dr. Raj Kumar Gupta approached to Hon'ble High Court by way of SWP No. 764/2017 in which he has challenged the orders of his transfer to Poonch on security grounds.

Whereas the Hon'ble High court in SWP No.764/2017 MP No. 1/2017 titled Raj Kumar V/s State & others has observed as:

"In view of the aforesaid submissions and in the facts of the case, as there is threat to life of the petitioner, I deem it appropriate to dispose of the petition with the direction to respondent No.1, namely Commissioner-cum-Secretary, Animal / Sheep Husbandry Department to decide the representation of the petitioner, which he has already submitted, by a speaking order, within a period of one month, from date of receipt of certified copy of the order passed today. Till then, the petitioner shall be permitted to continue in the office of respondent No.2, namely Director, Animal/Sheep Husbandry Department, Jammu. It is made clear that this Court has not expressed any opinion on merits of the claim of the petitioner".

Whereas, Dr.Raj Kumar Gupta has submitted Joining to the Director, Animal Husbandry Department Jammu on 01.04.2017 (FN) as per the Hon'ble High court order issued on 30.03.2017 and has further requested to release his pending salary from the month of January, 2017 to March, 2017.

Whereas, Dr.Raj Kumar Gupta has submitted a representation in the department in which he has intimated that he has served in the Army as a Short Service Commissioned Officer w.e.f Nov.1989 to Nov.1999 and further informed that during his tenure in the Army he was posted in the Surankote and has commanded 8 Mobile Field Veterinary Hospital w.e.f June 1995 to March 1998 and while in Army, his official residence at Surankote was blasted and even his unit 8 Mob Field Veterinary Hospital came under severe attack by the militants twice in the year 1997. Being an Ex-Army Officer, he has militant threat, even today as well.

Whereas, his representation was examined in the department, and after its examination has been considered in light of the orders of the Hon'ble High Court of Dated 30.03.2017

Now, in compliance to orders passed by the Hon'ble High Court, Dr.Raj Kumar Gupta, I/c Livestock Development Officer is posted as I/c Poultry Development Officer, Udhampur against available vacancy.

The Period of the absence of the officer from duty shall be decided separately.
