Subject:- Suspension of Dr. Ravinder Singh, Veterinary Assistant Surgeon.

**Government Order No: - 84 -ASH of 2017**

Whereas Director Animal Husbandry Jammu vide his communication No. DAHJ/E-2309 dated 03.01.2017 has reported that Dr. Ravinder Singh, Veterinary Assistant Surgeon, VD Tensna (Doda) remained under police custody w.e.f 12.09.2016 to 17.09.2016 under FIR No. 104/2016/U/S/452/307/34 RPC.

Whereas Director Animal Husbandry Jammu initiated action under rules 31 (1) & (2) of J&K Civil Services (Classification, Control & Appeal) Rules, 1956 and placed him under suspension vide his office order No.194-DAHJ of 2017 dated: 03.01.2017 on the basis of the case registered against him under FIR No. 104/2016/U/S/452/307/34 RPC.

Whereas aggrieved of the above order Dr. Ravinder Singh filed a SWP No. 816/2017 MP No. 01/2017 before the Hon'ble High Court of J&K. The Hon'ble Court vide its order dated 06.04.2017 disposed of the writ petition with the following directions:-

"In case the petitioner approaches the competent authority by filing an application for revocation of the order of suspension, the same shall be decided by the competent authority within a period of three weeks from the date of receipt of the certified copy of the order passed today"

It was further ordered by the Hon'ble Court that:-

"Till then, the operation and effect of the order of suspension dated 03.01.2017 shall remain stayed".

"Needless to state that the petitioner shall be paid the subsistence allowance for the period of suspension if the same has not already been paid to him".

Whereas, as per the directions of Hon'ble High Court the representation of the Dr. Ravinder Singh has been considered by the Department

in terms of CCA Rules 1956 as well as the facts of the case and it has been found that the suspension of the officer needs to be revoked.

Keeping in view the above position of the case, it is hereby ordered that the suspension order No.194-DAHJ of 2017 dated 03.01.2017 issued by the Director, Animal Husbandry Jammu is hereby revoked with immediate effect. However, the order shall remain subject to the outcome of the court orders /judgement.
