Sanction is accorded to the purchase of Thirteen(13) Units of TATA 712 LPT DCR 38 CBC-125 B6MS TT BS-VI with 125 HP Engine Tilt & Telescopic Power Steering 4.24 TONS Payload & 17.12 FT DECK LENGTH, Cabin Chasis" including fabrication, additional cost of fixing hydraulic tail/lift, insurance, registration, toll tax etc with cabin and high Deck load Body in favour of Director Animal Husbandry Jammu under the component "Purchase of Mobile Veterinary Clinics"-Capex Budget 2020-21.

The above sanction is subject to following conditions:-

- i. That vehicles shall be purchased through J&K State Motor Garages.
- ii. That no fresh posts of driver are created.
- iii. All codal formalities shall be fulfilled while procuring the said vehicles.
- iv. Condemned vehicles, if any, is put to auction & proceeds remitted into Government Treasury.
- v. No diversion of fund is allowed and there shall be no re-appropriation at any level.


