Terms of reference of the committee:

- i. Director, Sheep Husbandry Department, Kashmir shall ensure purchase of livestock that has reached optimum level of cross breeding through the committee from stationary breeders.
- ii. Purchase committee shall ensure that all codal formalities/procedures and other instructions issued by Finance Department from time to time are adhered to while effecting purchases.
- iii. In case a district is not in a position to meet the requirement locally, purchase will be made from other districts on requisition by the purchase committee of the intending district. Minutes of the purchase committee meeting shall be submitted to Director, Sheep Husbandry Department Kashmir, invariably.


