3. Accounts Officer shall vouchsafe the utilization of funds as per codal procedure and submit the Red account to the office of Principal Accountant General thereby adjusting the advance drawal immediately under intimation to the Administrative Department.
4. The funds are available for the said activity/work under Capex Budget 2020-21.
5. It must be ensured that no overlapping of funds from any other sources such as SDRF, District Plan, CSS, BADP, PM's Package, CDF, MPLADS etc.


