
Sanction is accorded to the purchase of 06 Units of Ambulances ( 01 unit Force Traveller Ambulance BS-VI FM 2.6 CR 3350MM WB (10+P) PS ABS Non AC Type B and 05 units of Force Traveller Ambulances Type-BS VI FM2-6CR-3350MM WB (10+P) PS ABS AC Type-B) alongwith Advance Drawal of ₹100.00 lac(Rupee One Crore) Only, in favour of Director Animal Husbandry Jammu , under the component Purchase of Ambulances, out of Capex Budget 2020-21.

**The above sanction is subject to following conditions:-**

1. The Ambulances shall be purchased through J&K State Motor Garages on GeM portal.
2. No post of Driver shall be created.
3. The Department shall utilize the funds after ensuring the strict compliance of all due procedures and codal formalities as prescribed under GRF and Manual procurement of Goods and Services.
4. The expenditure shall be incurred with prior approval of competent authority.
5. The Department shall avoid idle parking of money in the account.
6. The Department shall ensure that vehicles are received with due inspection and certification.
7. The funds shall not be available for re-appropriation or diversion/deviation at any level
8. The Red DC Account of the Advance drawal shall be furnished to all the concerned quarters within stipulated time but before 31.03.2021.
