Sanction is hereby accorded to the constitution of Single Nodal Agency (SNA) for regulation of the flow of funds through PFMS for Centrally Sponsored Schemes (CSS) of Animal / Sheep Husbandry and Fisheries Department under the title Administrative Secretary, Animal / Sheep Husbandry & Fisheries Department.

The Centrally Sponsored Schemes (CSS) of Animal / Sheep Husbandry and Fisheries Department to be regulated by the SNA are as follows:-

- (i) National Live Stock Mission (NLSM);
- (ii) Assistance to States for Control of Animal Diseases (ASCAD);
- (iii) Establishment and Strengthening of Veterinary Hospitals and Dispensaries (ESVHD);
- (iv) Integrated Sample Survey (ISS);
- (v) 20th Livestock Census & PPR-CP;
- (vi) Pradhan Mantri Matsya Sampada Yojana (PMMSY).

The Single Nodal Agency shall open a separate account for each scheme.




