- a) Reimbursement of charges is restricted to items/procedures admissible under Rules for the period of hospitalization w.e.f. 09-08-2016 to 19-08-2016 and cost thereof is restricted to the extent of rates, applicable to such items/procedures at PGI Chandigarh.
- b) All relevant medical bills/vouchers are verified and countersigned by the competent medical authority of the hospital wherefrom treatment has been undertaken.
- c) Referral/ certificate from the competent authority to the effect that the treatment was not available in Government, Hospital or Institute of the State.
- d) Follow-up(s), if any are regulated under rules.


