Sanction is, hereby, accorded to the release of Grant in Aid of **Rs 25.00 lac** (Twenty Five Lakh Only) as Central Share under "**20th Livestock Census**" in favour of Director Animal Husbandry Kashmir through BEAMS under No.pdaahd1/AHD/Plan/Capex-Bgt/2018-2019/9/16 dated 21.9.2018 for its utilization during 2018-19.

The release of funds is subject to fulfilment of all codal formalities, procedural norms and following conditions:-

- i. That the funds shall be utilized for execution of the scheme strictly as per originally approved components and according to Government of India's prescribed guidelines;
- ii. That the Head of Department shall send a status report/MPR about the scheme, in terms of physical and financial progress made during the current year and up to date cumulative expenditure and physical achievement;
- iii. That the Head of Department shall send utilization certificate of the funds released as early as possible, and definitely well before 31.03.2019;
- iv. That the Accounts Officer concerned shall vouchsafe the utilization of funds as per codal procedure/ Government of India's guidelines;
- v. That the drawing and disbursing officer shall ensure that funds released are utilized prudently and judiciously and in no case they should book the expenditure just for the sake of spending;
- vi. That the HODs shall furnish monthly progress report (both physical and financial) to the Administration Department for its submission to Government of India.
- vii. There shall be no diversion of funds and funds will be utilized strictly on approved components of the scheme & strictly as per guidelines governing the scheme.
