The authorization of this amount is subject to the following conditions:-

1. The Department shall ensure that the budgetary provisions already earmarked for scheme / project shall not be allowed for re- appropriation / utilization for any other scheme or project.
2. The works should be got executed after the accord of Administrative Approval and Technical Sanction by the Competent Authority.
3. All works need to be executed under Government Rules as per Codal procedures.
4. The DDO will maintain separate account in respect of each work sanctioned under Languishing / Priority Sector Projects.
5. The payment out of these funds should be made scheme-wise to the executing agencies.
6. The amount shall be spent in accordance with the details of schemes approved by the competent authority and no diversion of funds shall be made to any other scheme / project.
7. The Department shall send a status report about the implementation of schemes, physical and financial progress as per schedule to the JKIDFC.
8. The Nodal Officer shall vouchsafe the utilization of funds as per the Codal procedure / guidelines.
9. The project shall be completed within the specified time frame only.
10. The authorization is further subject to the conditions conveyed for execution of Languishing / unfunded and important projects from time to time.
11. That no payment is released for work graded Unsatisfactory (U) till their

grading is improved by the concerned agency in terms of relevant provisions of the contract.

12. That the liquidity damages are imposed in terms of relevant clause of conditions of contract (GCC) in respect of the project / scheme, wherever required.
13. That the payment is restricted to the contracted cost only and will be subject to the condition that no cost overrun of any kind is to be paid.
14. That the Bank Guarantees for performance security / advances where requiring revalidation are obtained and revalidated well in time.
15. That the recovery on account of statutory deductions / taxes is deposited with the concerned Department / Agency in time.
16. That the recovery on account of advances is not utilized for payments.
17. Deviation, if any, shall be the personal responsibility of the DDO.
18. That the above works have been qualitatively checked and found satisfactory.
19. That the TDS on account of GST is deducted and deposited with concerned quarters.

The sanction order is issued on the guarantee given by Chief Animal Husbandry Officer Reasi (Nodal Officer) that all the aspects of the projects have been duly confirmed as indicated in the invoice, UC and other documents viz., Image, Pre & Post HPC, M- Book / GR Sheet, M&P division bills, certificate of allotment of work viz., e-tendering and allotment of works to the contractor (s)
