Subject: Appointment of Veterinary Assistant Surgeon in Animal/Sheep Husbandry Department.

Whereas, the J&K Public Service Commission vide letter No. PSC/DR/VAS/2019 dated 05.04.2019 forwarded selection list of Veterinary Assistant Surgeons of Animal / Sheep Husbandry Department where under among others, selection of Dr. Tanveer Ahmad Sofi S/o Abdul Ahad Sofi R/o Arampora Tehsil and District Kupwara figuring at S.No.187 under OM/PHC category was also recommended; and

Whereas, after receiving the selection list, the Department issued formal appointment orders in favour of 197 selected candidates including Dr. Tanveer Ahmad Sofi as Veterinary Assistant Surgeon in Sheep Husbandry Department vide Government order No. 59-ASH of 2019 dated 22.04.2019 and subsequently posting orders vide Government order No. 71-ASH of 2019 dated 03.06.2019; and

Whereas, after issuance of appointment order, the department received a communication No. PSC/DR/VAS/2018 dated 30.05.2019 from J&K Public Service Commission, stating therein that the case of Dr. Tanveer Ahmad Sofi S/o Abdul Ahad Sofi R/o House No. 03, Hayat Colony, Drugmulla has been referred to Standing Medical Board, Government Medical College Srinagar for review of two contradictory Medical certificates and till such time, the findings of the Standing Medical Board GMC, Srinagar are received by the Commission, the appointment order of Dr. Tanveer Ahmad Sofi figuring at S. No. 187 in the select list may be put on hold; and

Whereas, the Department vide Government order No. 83-ASH of 2019 dated 18.06.2019 kept the appointment / posting orders issued vide Government order No. 59-ASH of 2019 dated 22.04.2019 & Government order No. 71-ASH of 2019 dated 03.06.2019 in respect of Dr. Tanveer Ahmad Sofi S/o Abdul Ahad Sofi figuring at S No. 187 & 106 respectively in abeyance with immediate effect; and

Whereas, the Jammu & Kashmir Public Service Commission, vide letter No. PSC/DR/VAS/2018 dated 28.07.2021 read alongwith PSC/DR/VAS/2018 dated. 01.02.2022, has intimated that in view of the findings of the Special Medical Board constituted by the Health & Medical Education Department vide Government order No. 200-JK(HME) of 2021



dated 17.03.2021, the communication bearing No. PSC/DR/VAS/2018 dated 30.05.2019 of J&K Public Service Commission treated as withdrawn/deleted; and

Therefore, in view of the above, the appointment of Dr. Tanveer Ahmad Sofi S/o Abdul Ahad Sofi R/o House No. 03, Hayat Colony, Drugmulla as Veterinary Assistant Surgeon in Sheep Husbandry Department is restored notionally w.e.f 22-04-2019 and monetarily with immediate effect. He shall be on probation for a period of two years and other terms and conditions of his appointment shall remain same as are given in Government Order No 59-ASH of 2019 dated: 22.04.2019. Subsequently, Dr. Tanveer Ahmad Sofi is also posted as Veterinary Assistant Surgeon, Handwara in Sheep Husbandry Department against an available vacancy.


