**Subject: Transfer and posting of Veterinary Assistant Surgeons.**

**Government Order No: 21 - JK (APD) of 2022  
Dated: 20 .05.2022**

Whereas, Dr. Sahadat Ali has been appointed Veterinary Assistant Surgeon vide Government Order No. 59-(ASH) of 2019 dated 22.04.2019 under SRO 202 of 2015 dated 30.06.2015 and was posted as Veterinary Assistant Surgeon, Karnah Kupwara vide Government Order No.71-ASH of 2019 dated 03.06.2019;

Whereas, Dr. Sahadat Ali submitted an representation to the Administration Department, wherein, he has stated that he has been diagnosed as a patient having Motor Neuron Disease and needs regular physiotherapy follow-up at Composite Regional Institute, Bemina, Srinagar for Speech Therapy, Mobility Training and other rehabilitation trainings and has been advised to follow Neurology Department at Government Super-specialty Hospital, Srinagar on regular basis, for which, he needs to stay near composite Regional Institute, Bemina, Srinagar;

Whereas, the case was examined by the department and was referred to the Chairman, Medical Board, Government Medical College, Srinagar vide letter No. ASHF/SHOGAZ/5/2021-03 dated 12.08.2021 to place the case before the Standing Committee in order to ascertain, whether, the Veterinary Assistant Surgeon is medically fit to be posted in far-flung area;

Whereas, the Member-Secretary of the Standing Medical Board, Government SMHS Hospital, Srinagar vide letter No.MB/SMHS/6737 dated 25.09.2021 has intimated that the case of Dr. Sahadat Ali stands examined by the Standing Medical Board of the Hospital on 18.09.2021. The findings of the Standing Medical Board are reproduced below:-

**“Patient is provisionally diagnosed as Spiro-Cerebeller ataxia and is assessed by Neurologist Super-Specialty GMC, Srinagar. He is advised to undergo regular physiotherapy and is advised to follow Neurology Department, GMC Srinagar on constant basis. He is advised to stay in Srinagar City for the same.”**

Whereas, in terms of rule-6 of S.O.192 of 2020 the appointee under these rules shall have to necessarily work for a period of five years on the post against which he has been initially appointed shall not be eligible for transfer for what-so-ever reason;

Whereas, the case was examined in the Department in this backdrop and the Animal/Sheep Husbandry Department was not in position to transfer the incumbent in view of the instructions laid down in the aforementioned S.O;

Whereas, it was further examined and decided to submit the case to Hon'ble Lieutenant Governor for relaxation of Rule-6 of the Jammu and Kashmir, Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020;

Whereas, the GAD vide U.O No.GAD-CORD/28/2022 dated 19.04.2022 have returned the case file & conveyed their agreement to the Departmental proposal for transfer of Dr. Sahadat Ali, VAS, Karnah Kupwara to Srinagar on health grounds;

Now, therefore, in view of the above, sanction is hereby accorded to the transfer and posting of the following veterinary Assistant Surgeons of Sheep Husbandry Department, Kashmir with immediate effect:-
