Ex-post-facto sanction is hereby accorded to the reimbursement of medical expenses incurred by Dr Mohd Ishaq Bhat, Clinical Pathologist, Animal Husbandry Department, Kashmir on the treatment of his wife at Rajiv Gandhi Cancer Institute & Research Centre Delhi in relaxation of rule 6(1) of the J&K Civil Services (Medical Attendance and Allowance) Rules, 1990, subject to the following conditions:-

- Reimbursement of charges shall be restricted to items/procedures admissible under rules for the period of hospitalization and cost thereof restricted to the extent of rates as applicable for such items/procedure at AIIMS New Delhi, Further, reimbursement of the claim shall be admissible only for the expenses incurred beyond the amount/package that was admissible under the J&K Group Medclaim Insurance Policy which was operational at that time.
- All relevant medical bills/vouchers are verified from relevant Medical Authority of the hospital where from treatment has been taken.
- Essentiality certificate on Form 2 issued by the hospital authorities is obtained and kept on records.
