**Whereas**, vide Government Order No. 69-ASH of 2017 dated 23.05.2017, Dr. Suhail Ahmad Bhat was appointed as Veterinary Assistant Surgeon in Animal Husbandry Department; and

**Whereas**, Dr. Suhail Ahmad Bhat, Veterinary Assistant Surgeon applied for the post of Assistant Professor, Veterinary Technology in Higher Education Department through proper channel; and

**Whereas**, Dr. Suhail Ahmad Bhat, Veterinary Assistant Surgeon tendered his resignation in the office of Chief Animal Husbandry Officer, Pulwama w.e.f. 24.02.2024 on the grounds that he has been appointed as Assistant Professor, Veterinary Technology in Higher Education Department; and

**Whereas**, the Director Animal Husbandry, Kashmir vide No. PF-324/DAHK-Estb0PFS/165/2023-2-1/416028/2024 dated 01.07.2024 recommended his technical resignation thereby asserting that there is no RDA/Vigilance Case or outstanding pending against Dr. Shabir Ahmad Bhat, Veterinary Assistant Surgeon.

**Now, therefore**, in terms of Rule-201 of J&K CSR Vol-I, other enabling provisions and on the recommendations of Director, Animal Husbandry Kashmir, technical resignation of Dr. Suhail Ahmad Bhat, Veterinary Assistant Surgeon is hereby accepted and is discharged from the J&K Animal Husbandry (Gazetted) Services w.e.f. 24.02.2024.
