Whereas, on the recommendation of J&K Public Service Commission, Dr. Sajad Ahmad Sheikh S/o Ali Mohammad Sheikh R/o 268-Peth Bugh Dialgam District Anantnag was appointed as Veterinary Assistant Surgeon under EWS category in Sheep Husbandry Department, J&K vide Government Order No. 600-JK(APD) of 2023 dated 19.12.2023 and was posted as VAS Gool in the organization of District Sheep Husbandry Office, Ramban vide order No. 153-SHDJ of 2024 dated 01.03.2024;

Whereas, the Director, Sheep Husbandry, Jammu vide his letter No.DSHJ-ESTT0GAZ/14/2024-01/6661-62 dated 07.08.2024 has intimated that Dr. Sajad Ahmad Sheikh, has been appointed as Subject Matter Specialist T-6 (Animal Science) in ICAR-Central Institute of Temperate Horticulture, Srinagar vide Order No.F.2-2(2)/Estt/Tech/1469-77 dated 17.05.2024 and accordingly he has tendered his resignation from the post of Veterinary Assistant Surgeon on 20.05.2024.

Whereas, the matter has been considered with reference to the rules governing the subject and it has been found that Dr. Sajad Ahmad Sheikh is still on probation on account of which he is liable to be discharged from the service by terminating his probation in terms of Rule 21(1)(b) of Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956 on his own request.
