The Accord of Administrative Approval, however, is subject to the following conditions:-

 That works are executed strictly as per the details enclosed at Annexure "A" and Annexure "B" and item-wise reflections in original DPR duly vetted by Development Commissioner works and all codal formalities as contained in GFR 2017 be adhered to in letter & spirit before / during the execution of work.

2. That proposal is strictly devised and designed as per latest relevant I.S codes and specifications of MoRTH/PWD/CPWD and same is authenticated and proof checked by the competent authority (NIT/DIQC) before taking up execution in hand.

3. That Electrical /Mechanical /Electrical Components are authenticated and technically vetted by the Competent Authorities of relevant field.

4. That the standard specifications are followed as per CPWD, NBC and I.S standards.

5. That the specifications as defined in CPWD approved plinth area rate schedule for the type of structures, proposed in the DPR, are followed and adopted for execution of works.

6. The rates for the items, not covered in JK SSR or any other relevant schedule, shall conform to analysis of rates based on authentic Data Book, to be computed and

approved by the Competent Authority well before invitation of tenders in

accordance with set codal procedures.

7. That the lump-sum provisions, either in terms of percentage or fixed as made for certain components of the DPR are provisional and shall be subject to detailed estimates based on actual details / requirements and relevant rates, to be framed and approved by competent authorities well before invitation of tenders in accordance with set codal procedures.

8. That the working BOQs, based on approved design details/requirements, are framed as per J&K PWD Schedule of Rates for e-tendering purpose of the Project.

9. That E-tendering mode and other codal procedure as mandatory is followed for finalization of award of contract for execution of the project. Fragmentation of project, while tendering, is not allowed.

10. That the Technical vetting is exclusively for the purpose of Accord of Administrative Approval and shall not be constructed as any rate approval to the projects or any

approval for inclusion in the plan.

11. Encumbrance free land is available for the execution of the project.

12. Technical sanction is in place before execution of the project.

13. That the timeline is strictly adhered to. No cost escalation / time over-run shall be admissible under any circumstances, what so ever.

14. The necessary load bearing capacity test of soil shall be undertaken at site.

15. This AA is being issued as per NABARD funding guidelines and does not authorizes Director Fishery to undertake execution of work without sanction form NABARD.

16. While designing, adequate provisions in design need to be incorporated for making the structures resistant to earthquakes to avoid any loss of property / life.
