Sanction is hereby accorded to the advance drawal of funds amounting to ₹12.65 Crore (Rupees Twelve Crore and Sixty-Five Lakh Only) in favour of Director, Sheep Husbandry Department, Jammu for the Importation of Livestock (Dorper Breed of Sheep) under the Holistic Agriculture Development Programme (HADP) Project Reorienting Priorities-Self Sustenance in Mutton Production, during the current financial year 2024-25, subject to the following conditions:-

- 1. The expenditure sanction for the procurement proposal should be ensured as per delegation of financial powers and compliance of GFRs and CVC guidelines.
- 2. The funds shall be utilized after following all the provisions of GFR.
- 3. The funds shall be utilized for the purpose for which these are meant for and expenditure shall be incurred strictly under rules after completing all codal formalities, procedural norms, financial rules and regulations issued by the Government from time
- 4. The funds should not be kept idle in the account & disbursed immediately.
- 5. No diversion of funds is allowed and there shall be no re- appropriation at any level and no liability should be created.
- 6. Accounts Officer, Directorate of Sheep Husbandry, Jammu shall vouchsafe the utilization of funds as per codal procedure and submit the Red Account to the concerned quarters well in time.
- 7. The funds are available for the current financial year, 2024-25 for said purpose under the relevant Head of Account / Scheme.
- 8. All the formalities for the Importation of the Livestock shall be fulfilled as per terms and conditions of the Global Tender.
