The appointee(s) shall report to the concerned Directorate, Animal Husbandry Department, Jammu/Kashmir within a period of (21) days from the date of issuance of this appointment order. In case the candidate fail to join within the stipulated time, shall forego his right to appointment, and the same shall be deemed to have been cancelled *ab-initio* without any further notice.

The appointee(s) shall be allowed to join, only on the production of the following certificates (in original) to be verified subsequently:

- i. Academic/Qualification Certificates.
- ii. Matriculation/Date of Birth Certificate.
- iii. Health Certificate from the concerned Chief Medical Officer of the District.
- iv. Domicile Certificate issued by the Competent Authority.
- v. That if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. He/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the Drawing & Disbursing Officer concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- vi. Valid relevant Category Certificate, if any applicable.

The appointment of the above candidate shall further be subject to the following conditions:

- a. The appointee(s) shall furnish an Undertaking in the shape of an Affidavit as per Annexure-1 to this Order;
- b. The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in respect of genuineness of Qualification/Date of Birth and Relevant Category Certificate is received from the concerned Authorities/Agency.
- c. The appointee(s) shall be on probation for a period of two years.
- d. The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- e. The inter-se-seniority of the appointee in the J&K Animal/Sheep Husbandry (Subordinate) Service shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.

- f. The appointment of the above appointee(s) shall be cancelled ab-initio, if it is found that he/she possesses higher qualification than the prescribed one at any stage and he/she shall also be liable for criminal prosecution under law.
- g. The appointment of the above appointee shall be subject to outcome of writ petition(s), if any, pending before Competent Court/Tribunal etc.


