Sanction is hereby accorded to the opening of one (01) number of Zero Balance Account (ZBA) and one (01) corresponding Holding Account, in J&K Bank Ltd. under the **CSS-Assistance to States for Control of Animal Disease (ASCAD)** to be operated by Superintendent Central Veterinary Hospital, Srinagar.

**However, the authorization so conveyed shall be subject to the following conditions:-**

1. The department shall ensure that no such account is operative in any Bank(s). Besides, the account shall be specifically operated for the operation of above mentioned Scheme.
2. Account shall be opened preferably in the same bank as is the SNA / ZBA Account.
3. Maximum time for which money can be held in this account shall be fourteen days, after which the money shall be credited back to the Agency Account.
4. The money is not kept idle in the account in any form & parking of funds is strictly avoided.
5. The account is not misused in any form and is used for approved activities only.
6. The procedure for release of funds under the CSS and monitoring, utilization of the funds released by the GOI, Ministry of Finance, Department of Expenditure PFMS Division dated 23.03.2021 and the instruction(s) issued thereof from time to time shall be strictly adhered to.
