As recommended by J&K Services Selection Board, sanction is hereby accorded to the temporary appointment of **Mr. Irfan Nabi Mir S/o Gh. Nabi Mir R/o Namblabal, Pampore, Pulwama** against the post of **Class-IV in District cadre Pulwama** under **OM category**, in **Animal Husbandry Department, Kashmir** in the pay Level-SL1 (14800-47100) in terms of the Jammu and Kashmir Probation (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020, notified vide S.O 192 dated 17.06.2020.


The appointee shall report to concerned Director, Animal/Sheep Husbandry & Fisheries Department, Jammu/Kashmir within a period of (21) days from the date of issuance of this appointment order. In case, of failure of the appointee to join within the stipulated period of 21-days, his appointment shall be deemed to have been cancelled ab-intio without any further notice.

The appointee shall be allowed to join, only on production of following documents, which shall be verified subsequently:-

1. Academic Qualification Certificate
2. Matriculation / DOB Certificate
3. Health Certificate by concerned CMO.
4. Domicile Certificate
5. Relevant category certificate (in case candidate belonging to the Reserved Category)
6. Certificate from concerned authorities to the effect that no loan under Self Employment Scheme has been obtained/ availed by the concerned candidate.
7. Undertaking regarding no criminal records
8. Any other relevant certificate as required under rules.

The appointment shall further be subject to the following conditions:-

- i) The appointee shall be on probation for a period two years and the salary of appointee shall not be drawn and disbursed to him unless a satisfactory



- verification report in respect of academic qualification/other certificates is received from the concerned authority.
- ii) The inter-se seniority of the candidate shall be reckoned as per the merit furnished by the J&K SSB **and for the purpose of seniority only, the date of appointment shall be 22.10.2021 of the appointee.**
 - iii) The appointment shall be cancelled ab-initio, if it is found that the candidate is having higher qualification than the prescribed one at any stage later on, and he shall also be liable for criminal prosecution.
 - iv) The appointment order shall be subject to outcome of any petition/(s) pending in any competent court/Tribunal etc.
