**Subject:- Accord of Administrative Approval for Construction of
Central Veterinary Hospital at Athwajan, Srinagar**


Government Order No. **191** -ASH of 2021

In exercise of the powers conferred vide S.O No. 15 dated 09.01.2020 issued by the Finance Department, Administrative Approval is hereby accorded to **"Construction of Central Veterinary Hospital at Athwajan, Srinagar"** at an **estimated cost of Rs. 1063.59 lacs(Rupees Ten Crores, Sixty Three Lacs and Fifty Nine Thousand)** only, to be taken up under NABARD Loan assistance, in favour Director, Animal Husbandry, Kashmir.

The above Administrative approval is subject to fulfillment of all codal formalities, procedural norms and the conditions laid down by the Development commissioner (Works) vide No. PW/DCW/R&B/DB/709/2020 dated 06.03.2020 that:-

1. the proposal is strictly devised and designed as per latest relevant I.S codes specifications of PWD/CPWD and that the other relevant rules, Procedures and guidelines are strictly followed during the execution of works.
2. the structural design of the project is got authenticated and proof checked by the by competent authority well before execution of the works and while designing latest HFL is also taken into consideration for flood prone locations.
3. the building plan and other relevant drawing of the project are got authenticated by competent authority well before execution of the works.
4. there is no time or cost overrun involved in the project and set time line is strictly adhered to. No escalation shall be admissible under any circumstance.
5. the specification are followed, electrification and other amenities are provided, as specified in CPWD PAR-2009 for the type of structure, proposed in the DPR.
6. the rates for the items, not covered in JKSS or any other relevant schedule, shall conform to analysis of rates based on authentic data book, to be computed and approved by competent authority well before invitation of tenders in accordance with set codal procedures.
7. NOC from Regulatory Authorities/PCB are sought before commencement of work;
8. the items related to the quantity of earth work conforming to the authenticated NSLs design cross section and L section. Moreover pavement design shall be based on CBR test result.
9. the Electrical/ mechanical Components are authenticated by Competent Authorities well before execution of work takes place;
10. Encumbrance free land is available for the execution of the project.
11. Any such item(s) not covered under relevant Schedule of Rates shall be paid in accordance with the set Codal Procedure;
12. stipulation as prescribed for Energy efficient/rain water harvesting/green

building may be adhered to.

13. specification as applicable under CPWD approved plinth rates of 2012 for proposed type of structure shall be adhered to.
14. building project will be declared physically completed only after completion of sewage disposal works/STP as per the ideal requirement.
15. e-tendering mode and other codal procedure as mandatory is followed for finalization of award of each project and working DPR is followed in the advertised BOQ. Fragmentation of project while tendering is not allowed.
16. Proper rate analysis and market survey is conducted in light of standing rules and procedures in case of all the items proposed to be executed on ground prior to issuance of formal NIT for the project, in order to ensure rationality of rate.
17. work must be completed within the authorized cost and specification and no liability shall be created over and above approved cost; and
18. No deviation of any kind shall be allowed at the time of execution.
