1. This temporary interim arrangement shall never confer any right for claiming these posts on permanent basis which shall always be subject to rules governing the service
2. The Government can revert back such officers to their substantive post at any time without assigning any reason.
3. If the performance of the officers is not satisfactory, any complaint or adverse report from any agency is received, the officers can be removed from such post.
4. This shall be without prejudice to the outcome of any court case (s) pending before any competent court of law.
