Subject:- Advance drawal of ₹50.00 lac for Insurance of Imported Livestock under Capex Budget 2020-21.



Sanction is accorded to Advance Drawal of **₹50.00 lac** (Rupees Fifty lac) only, in favour of Director Sheep Husbandry Kashmir out of Capex Budget 2020-21 for Insurance of imported Merino livestock.

The above Advance Drawl is subject to following conditions:-

1. No diversion of fund is allowed and there shall be no re-appropriation at any level and no liability should be created.
2. That the funds shall be utilized for the purpose earmarked for and the expenditure shall be incurred strictly under rules after completing all the codal formalities, procedural norms, financial rules and regulations issued by the Government from time to time.
3. Accounts Officer shall vouchsafe the utilization of funds as per codal procedure and submit the Red account to the office of Principal Accountant General thereby adjusting the advance drawal immediately under intimation to the Administrative Department.
4. The funds are available for the said activity/work under Capex Budget 2020-21.



5. It must be ensured that no overlapping of funds from any other sources such as SDRF, District Plan, CSS, BADP, PM's Package, CDF, MPLADS etc.
6. Financial norms approved under the scheme, as well as adherence to scheme guidelines and submission of pending UCs, if any.


