Whereas, vide Government Order No. 116-ASH of 2016 dated 11.11.2016, a common Final Seniority list of Gazetted Officers of Fisheries Department at all levels was issued. Thereafter, vide Government Order No. 140-ASH of 2019 dated 22.10.2019, a Final Seniority list of Gazetted Officers of Fisheries Department was issued except of Deputy Director(s), which was kept on hold owing to all pending claims/court cases filed by Mr. Abdul Majid Tak Deputy Director V/s Mr. Gopal Krishan I/c Deputy Director, with reference to his education qualification;

Whereas, the case was examined by the department and vide Government Order No. 143-JK(ASH) of 2021 dated 21.10.2021 a speaking Order was issued, where under it was indicated that the qualification of Mr. Gopal Krishan, I/c Deputy Director shall be treated as M.Sc Zoology with specialization in Entomology and his promotions/seniority at different levels availed by him shall be ascertained in consultations with J&K Public Service Commission, in accordance with the rules;

Whereas, some changes have occurred in the seniority list due to promotion/retirement of some officers and it has become expedient to issue fresh/up-to date seniority list of officers of Fisheries Department;

NOW THEREFORE, a tentative seniority list of Deputy Director(s) of Jammu and Kashmir Fisheries Department as it stood on 01.01.2021, forming **Annexure** to this notification is hereby notified for information of all concerned.

This seniority list shall be without prejudice to the final outcome of any Writ Petition(s), if any, pending in the competent Court of Law.

The date(s) of birth and category status of the officers recorded in the tentative seniority list shall not be taken as authentic and shall be subject to further verification with the Service book/matriculation Certificate issued in respect of these officers by the concerned authorities.


